Post: Managing Director

The Managing Director is the Chief Executive of the Company responsible to report to the Board of Directors as per the Articles of Association of RPCL. The position shall be responsible for managing all businesses and administrative function of the Company by anticipating and managing all the resources of the Company to achieve organizational goals. He is the leader of the Management Team of the Company, responsible for corporate planning, business development and ensuring the compliances of laws, rules and regulations as well as good governance. He is also responsible for supervision of all engineering, financial, welfare aspects of the Company, negotiating project financing issues with donors/development partners and liaise with the line Ministry, other government offices and authorities as and when required.

Required Qualification:

- (a) At least graduate in Electrical/Electrical & Electronic/ Mechanical/ Civil Engineering or Masters in Finance / Business Administration/ Management from any recognized university /institution.
- (b) No third Division/Class at any stage of the academic career shall be acceptable. Candidates passed in the grading system must possess at least a GPA/CGPA 3.0 on a scale of 5.0 and GPA/ CGPA 2.5 on a scale of 4.0.
- (c) At least 25 (twenty five) years of work experience of which at least 05 (five) years in senior management position not below the rank of Chief Engineer or equivalent.
- (d) At least 05 (five) years experience in generation utilities.
- (e) Must be able to demonstrate knowledge about relevant Government rules & regulations.
- (f) Must be able to demonstrate knowledge in Company Law, Labour Law, TQM, TPM, Preventive Maintenance, Corporate Governance etc.
- (g) Must demonstrate strong participatory leadership ability.
